

The Amazon Data Center

- Computer processing warehouse
- 220,000 square feet
- 52 feet high, incl AC units on top
- On 42 acre site on Blackwell Rd
- ½ mile from Northrock
- Proposed
- Requires Town Council approval

Also: 8-acre Substation

This is the current substation near the Fairgrounds

A larger version of this is planned to go on Blackwel, next to Giant Grocery – in full view of Northrock



Also: Transmission Lines



- 110 foot tall metal poles
- 100 foot ROW clearance
- Destruction of trees & vegetation
- Tarnishes Fauquier's rolling agricultural landscape
- Reduces property value
- Massive energy increase to accommodate more data centers

Blackwell: Wrong site, Wrong use

- Visual blight on gateway to Town
- Noise impacts on 657 nearby homes
- AC units on roof operate 24/7, 365 days/year
- Conflicts with Town Comp Plan which calls for mixed use "New Town" neighborhood
- 50,000 gallon diesel containers on site
- 8' prison type fencing all around perimeter

Data centers should not be near neighborhoods




Zero mention of data centers

The same day Town Council initiated zoning amendment for Amazon data center









Northrock **Will Likely** be the Most Visually and **Sonically Impacted Community**

- Measured 58.60 dBA at Northrock border
- This included ambient roadway noise
- This is raw Total dBA using International Standard
- Using Warrenton Frequencybased Standards likely to be higher
- Low Frequency (63 Hz to 2,000 Hz) likely to be audible and perceptible





How did this come about?

BEFORE 2021:

Data centers not in Town econ dev or Comp Plans

IN 2021:

Amazon & Town staff began meeting quietly Public was in the dark

Amazon helped Town Manager write zoning amendment to allow data center on Blackwell – contrary to Comprehensive Plan

Town Manager "dropped it on the consent agenda" Town staff sign "nondisclosure agreements" with Amazon

No public outreach, no effort to inform citizens Town Council votes to adopt zoning amendment for Amazon

IN 2022:

Amazon submits SUP application
Application grossly deficient, fails to
address all criteria
Town staff deem it complete anyway

Planning Commission starts review

Mid July: Town Manager resigns to spend

time with family

2 weeks later Town Manager is working for

Amazon

Nov-Dec: Town Council vote expected

Why?

\$ Profits for Dominion

\$ Tax revenue for the Town

At the expense of:

- Lost property value
- Health & wellbeing of citizens

Will the Town Council Approve It?


- Observers predict a 4-2 vote to approve Amazon

- Every voice is important




Once Approved, Data Centers Multiply Rapidly
